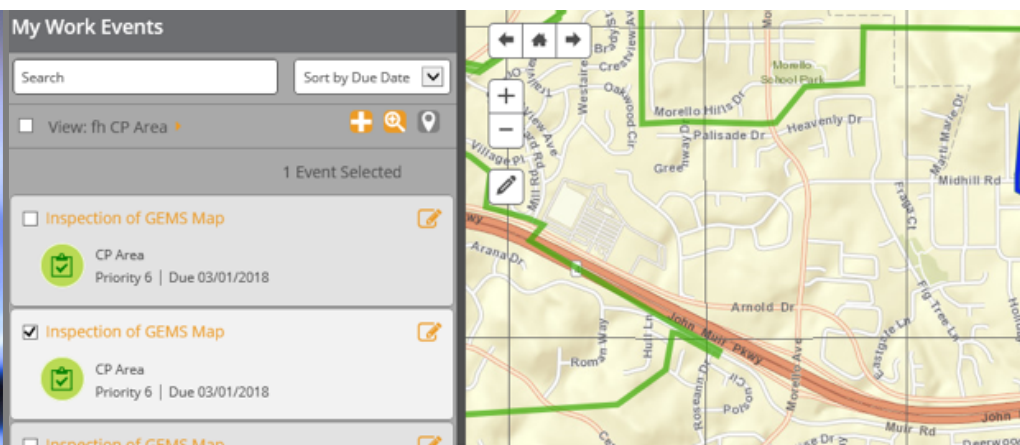

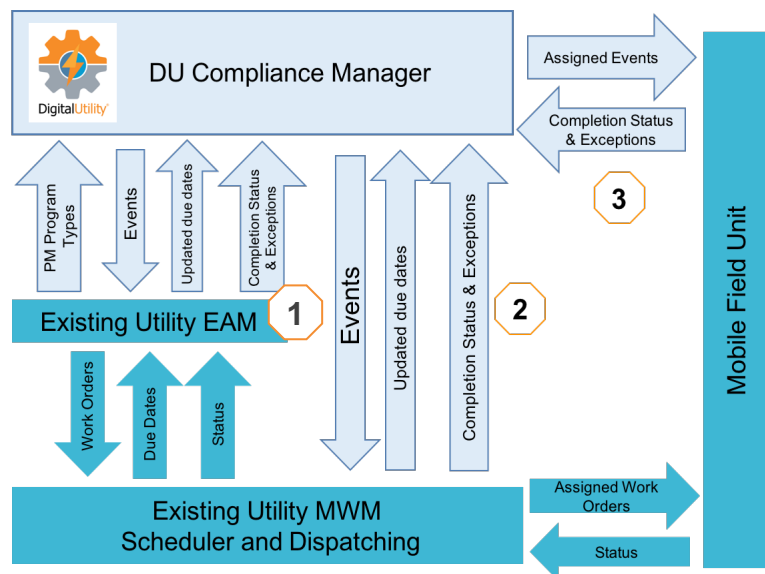

The application offers a mobile component that runs in Windows Mobile and IOS on Apple devices.



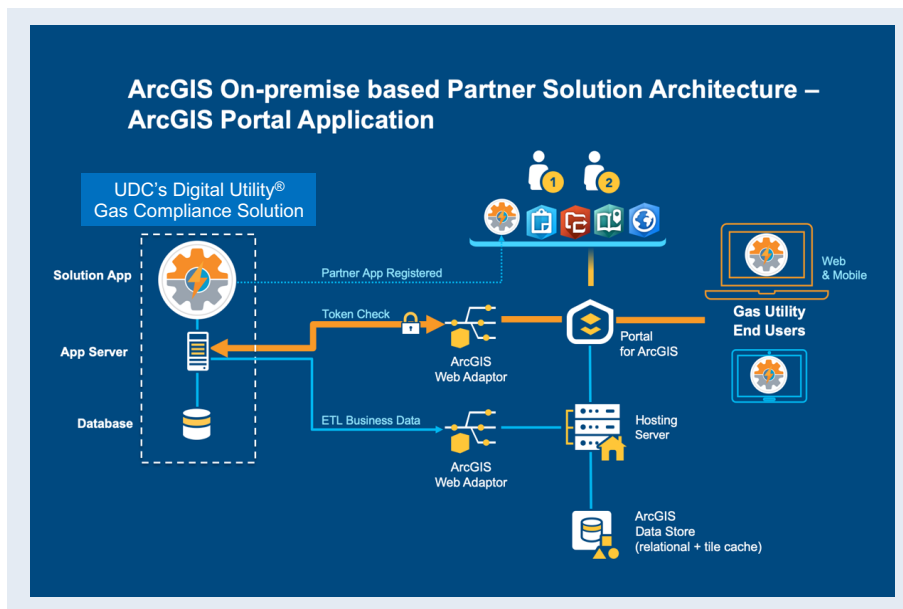

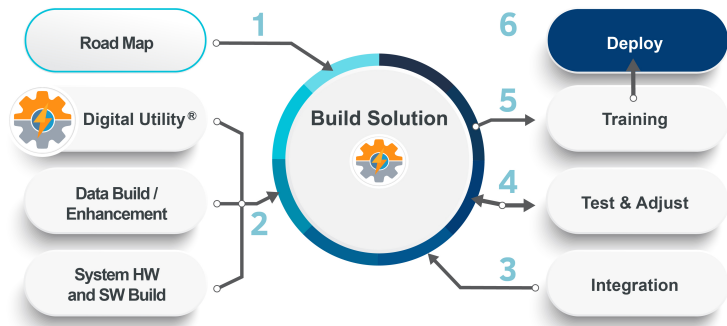
